## ANNUAL MIXED DOUBLES TOURNAMENT

1. This tournament is CTF sanctioned and all tournament and playing rules will be enforced. This tournament will be held on March 30 & 31 and April 6 & 7, 2019 at Brunswick Bramalea.
2. Only members of the Greater Toronto Tenpin Bowling Association holding a 2018-2019 membership card may enter this tournament. **Youth bowlers participating in Youth Leagues will not be permitted to bowl in this tournament.** A doubles team shall consist of a male member and a female member. This tournament permits unlimited entries, but a bowler may cash only once with the same partner. **Bowlers must show their 2018-2019 membership cards** (temporary receipt cards accepted) when checking in. A non-resident who is eligible for the association tournament in the association of residency may participate in this association tournament provided they have bowled a minimum of 21 games in this association as of January 1, 2019.
3. **Full payment must accompany entry form. Entry is not valid until all monies are received prior to the closing date March 8, 2019. ( POST-DATED CHEQUES WILL NOT BE ACCEPTED AND NO REFUNDS AFTER CLOSING DATE).** Make **cheques payable to the Greater Toronto Tenpin Bowling Association.**
4. Prize money will be awarded for both scratch and handicap divisions. Teams cannot cash in both Scratch and Handicap Division Prize funds. Prize money will be returned 100% on a ratio for at least 1 in 7 entries or major fraction thereof. 90% of prize monies will go to Handicap and 10% to the Scratch.
5. This is a handicap tournament based on 90% of the difference between the combined average of both bowlers and 460. We have no negative handicaps.

All bowlers will use their highest sanctioned league average based on a minimum of 21 games as of May 31, 2018. Anyone without a 2017-2018 average will use their highest 2018-2019 sanctioned league average for 21 games or more as of January 1, 2019. If the bowler has no average as per the foregoing, he or she may use a sanctioned summer league average (21 or more games) for 2018. All other entrants will bowl scratch.

**When using current average, verification from your league secretary must accompany the entry.**

**\*\*RULE 319a-2 IS IN EFFECT--"WHEN THE PREVIOUS SEASON'S AVERAGE IS USED, AND THE BOWLER HAS A CURRENT AVERAGE FOR 21 OR MORE GAMES (AS OF JAN 1, 2019) THAT IS 10 PINS OR MORE HIGHER THAN THE PRIOR SEASON'S AVERAGE, THE CURRENT AVERAGE MUST BE USED.**

6. Three games will be bowled on one pair of lanes. Entrant(s) who arrive late will be permitted to bowl and count score beginning with the frame being bowled.
7. The average of all prize winners will be checked. **FAILURE TO USE THE CORRECT AVERAGE SHALL DISQUALIFY SCORE IF THE SUBMITTED AVERAGE IS LOWER THAN THE CORRECT AVERAGE, THEREBY RESULTING IN A LOWER CLASSIFICATION AND MORE HANDICAP.** Prize winnings will be based on the submitted average if it is higher than the correct average. **IT IS THE RESPONSIBILITY OF ALL BOWLERS TO VERIFY THE ACCURACY OF THEIR AVERAGE (CTF Rule 16-A).**
8. CTF rules 319A, (1-4-5), 319C, 319D, 319E and **319A-2- 10 pin Increase rule and 319A-3- Reporting incorrect averages** shall apply to all CTF members.  
**A bowler is required to report prize money won in excess of \$300.00 in a single event, in excess of \$500.00 in the combined prize money, and/or in excess of \$1,000.00 in all tournaments competed in within 12 months.** Failure to comply is cause for a forfeiture of entry fee and prize winnings (CTF Rule 319D).
